He/she further agrees to follow the waste compost, disposal and recycling plan as posted in each cabin. Failure to comply will result in an additional \$25.00 fee.

2. **"Check in" time is 3:00 p.m. and "Check out" time is 11:00 a.m.**

3. Quiet time at Nanoose Bay Camp starts at 11:00 pm & ends at 8:00 am. Please advise the Camp Staff should you plan any late night activities. The main access gate will be locked at the Camp Staff's discretion unless otherwise arranged with the Camp Staff.

4. The use of candles or any other open flame device is prohibited at all times.

5. All youth and children must have adequate adult supervision. Equipment is to be used only with adult supervision.

6. Grounds, facilities and equipment must be maintained and left clean and tidy. Equipment must be returned to its proper place. Campground speed – 10 km at all times. Any items left/forgotten on the grounds will be held for 14 days only and will be disposed of at the discretion of NBPC staff.

7. **NOTHING FROM THE BEACH** - Cabin renters &/or their guests are not permitted to bring any items from the beach on to the camp property. This includes but is not limited to: shellfish, crab, seaweed, oysters or any other sea creatures: \* Initial: \_\_\_\_\_
