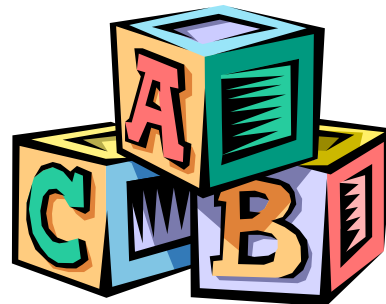

## CHILDREN'S DAY OUT

The program operates  
Tuesday through Friday  
9:00-11:30 am  
September through May.

Children may only come  
one day per week.

Children must be  
two or three years old  
to attend. A child cannot turn  
four during the school year.

Children do not need  
to be toilet trained.

There is a maximum of  
14 children per day  
with two teachers.  
This meets the state ratio of  
1:7 for toddlers.

**All children must be immunized.**



## REGISTRATION

Registration will be held in February for  
the following fall.

The children need to be  
two years old to start school.

Children who turn two  
after September 30  
may register throughout the year on or  
after their second birthday.  
They may need to be placed  
on a waiting list until  
space becomes available.

We follow all of the state requirements  
for safety, cleanliness, and staff trainings.

A registration fee of  
\$50.00 per child  
or \$90.00 per family is due  
with the registration form along with one  
month's tuition of \$70.00.

The registration fee is non-refundable.  
Tuition will be refunded if a two week  
written notice is given.

Spaces will be offered first to current  
CDO families, then to Epworth and ECEC  
families,  
and finally to the community.

## TUITION

Tuition is \$70.00 per month.

Tuition is due by  
the first class of each month.

A late fee will be applied  
if not paid by  
the 10<sup>th</sup> of the month.

## GUIDANCE AND MANAGEMENT

Expectations are set according to  
the age and ability of each child.  
Teachers will provide reasonable rules,  
determine logical consequences  
for breaking those rules, and be willing to  
give more responsibility to the children  
as they are ready to assume it. Teachers  
are responsible for classroom  
management, including modeling  
acceptable ways to behave at all times.

The guidance and management of CDO  
will be in accordance with  
section 5101:2-12-22  
of the Licensing Rules for the  
Ohio Department of Job and Family  
Services.

The rule applies to all staff and children  
at CDO.
