



The Karren Stinson Bursary Fund is an endowment fund established in 1990 by Lutheran Church of the Cross, Victoria, B.C., to celebrate the life of former parish worker Karren Stinson, who was stricken with an aneurysm and died on August 13, 1990, at the age of 32 years. In her six years of service at Church of the Cross, Karen contributed significantly to the life of the congregation, especially in areas of parish education, congregational programming, youth work and ELW ministry. In addition, she served on committees at the conference, Synodical, and national levels of Evangelical Lutheran Church in Canada. Karren resigned in order to attend the University of Victoria to pursue a degree in social work, with the goal of full-time church service. The purpose of this Fund is to give financial assistance to Christian persons currently involved in post-secondary education leading to a vocation of service. The first award was given in 1991.

THE BURSARY PROGRAM

The Karren Stinson Bursary Fund is directed and administered by a Committee consisting of one member from the Board of Education, three or more interested members appointed for rotating terms of three years, and a member-at-large.

The bursary program seeks to make an award to deserving students in pursuit of a post-secondary degree or diploma. The amount of the award will be between \$500-\$1000, based upon funds available. The award will be made on an annual basis, and recipients are eligible to re-apply in subsequent years.

ELIGIBILITY

Although the Board will make necessary judgments in all cases, the following general criteria will apply to awards:

- A. Applicants **must** be enrolled in full-time or part-time post-secondary studies.
- B. Applicant **must** be a Canadian citizen or have Permanent Resident status with a Social Insurance Number★
- C. Awards will be based upon the following equal criteria:
 - Academic Achievement, including Transcripts
 - Participation in community and church related activities
 - Christian Activities
 - Financial Need
 - Preparation for a career in the field of social services, education, ordained ministry or related church vocation
- D. Applicants must be active members of Lutheran or Anglican congregations and have a permanent address in Western Canada (Manitoba, Saskatchewan, Alberta, British Columbia, and the Yukon).
- E. The application and **two** letters of reference mailed to the address below (one pastor and one non-relative) are due by **October 31st** of the year in which the award is sought.
Awards will be made the following January.
