Approval of 2013 Annual Meeting Minutes - Rev. Joy Segal

Annual Meeting Minutes - May 5, 2013

Call to order - Rev. Joy Segal

The Meeting was called to order at 10:56am.

Election Announcements - Judges of Election

The Judges of Election (Megan Bartlett, David Hammond, and Jeanette Woehr) instructed the congregation on voting procedures. The instructions were to vote for no more than four candidates from the list below:

The polls were declared closed during the meeting and were to be reopened for a half hour immediately following adjournment of the meeting.

Approval of 2012 Annual Meeting Minutes - Rev. Joy Segal

A motion to approve the 2012 minutes as submitted was made by Jeanette Woehr and seconded by Peggy Buescher. The motion carried unanimously.

Rector's Report - Rev. Joy Segal

Joy reviewed the Parochial Report, noting that there was a decrease in pledged income from 2011 to 2012 and mentioning that budgeting is difficult without pledged income. However, she recognizes that church members don't pledge the same way they used to. She continued by saying that relationship-building is key for churches to thrive in the 21st century.

She mentioned four of Gloria Dei's partners, with whom we have the chance to deepen our existing relationships: Queen Village Neighbor's Association (QVNA), Young Children's Center for the Arts (YCCA); the National Park Service (NPS); and the Seamen's Church Institute (SCI). Church members were encouraged to be more connected to these four partners and to ask questions about them. It was emphasized that we cannot continue to financially support a full-time ministry at Gloria Dei if we don't connect with those outside of our walls.

Joy posed to us the question, "How can we convey to our neighbors the value of this church?" She encouraged us to be more invitational, to step out of our comfort zones, and share any ideas we have with the vestry.

Following the report, Jerry Buescher added that we should be proud of our attempts to form a new and lasting connection with Emanuel Lutheran Church, despite the fact that they chose to worship elsewhere. We were encouraged to remain open to the Spirit as this relationship evolves.

Rector's Warden Report - Jerome G. Buescher

Joy publicly thanked Jerry for his three years of service as Rector's Warden.

Jerry's report recapped the various activities and efforts at Gloria Dei this past year, including sending representatives to the Transforming Congregations workshops, developing new relationships, strengthening existing partnerships, celebrating 75 years of Lucia Fest, and struggling through financial constraints in order to present a balanced budget for 2013.

Following the report, David Hammond added that those who attended the Transforming Congregations workshops continue to work towards transforming Gloria Dei into a more thriving, viable community.

Financial Report - David Hammond

Dave recapped the financial report in which he stated that there has been a \$12,000 drop in congregational support and a \$5,000 drop in donations. In addition to that, our endowments brought in \$26,000 less this year than previous years. Some of these decreases were offset by an increased amount of revenue from fundraisers and a deduction in the amount of money given to the Diocesan Fair Share. However, we hope to increase our pledge to the diocese in future years. Dave added that our staff has not been given more than a bare minimum raise in several years, something which we also hope to change. If anyone has any questions or comments about the budget, please contact Dave.

Following Dave's report, Joy reminded us that the vestry approved spending money from the principle of one of our endowments, which we've been using as our "Growth and Transformation" fund to be used for outreach, advertising costs, and leadership development. Dave commented that he sees this as more of an investment than an expense. He added that the real estate value of the church is \$1.6 million, but these are not liquid assets.

Sunday School Report - Jill Duink and Julie Daye

Jill and Julie demonstrated to us the concept of Godly Play, which is the program our children are using in Sunday School. The children are learning about God by being moved by the Holy Spirit to explore and play using all their senses. Children are encouraged to wonder, ask, and explore. Godly Play emphasizes that renewal and growth come from the Spirit through connection with the world around us and with each other, not through rote memorization of facts.

Following the report, Joy encouraged us to witness this at work by attending a Sunday School class.

Property Committee Report - Rev. Joy Segal

Joy began her report by reminding us that we still don't have a property committee chairperson. Given the size of our property, it would be helpful to have a chairperson. If anyone is interested, please talk to Joy.

Joy's report mentioned the gravestone restorations and noted that we still have \$4729 available for graveyard restoration. She also mentioned many of the property projects completed since last year's meeting including roof and brick repair, tree maintenance, bush removal and plantings, overhead fans in Riverside Hall, pew kneelers recovered, new A/C unit for the 3rd floor of rectory, new floor in Riverside Hall, and others. The report listed property items to be addressed in the near future. Some graveyard restoration and/or property work in the coming year may be accomplished with donations or grants to the new 501(c)3, the Historic Gloria Dei Preservation Corporation. It was also noted that the Seamen's Church Institute will possibly be joining us in the coming years on our property in a newly constructed addition to Riverside Hall.

History Committee Report - Jeanette Woehr

Jeanette recapped the written report by saying that the archiving of written documents continues; the history committee is almost finished with those articles from the 1800s. In addition, the committee continues to work in the graveyard combining the various maps and names. The committee is always looking for new members; if you're interested, please contact Jeanette.

Hospitality and the Gift of Fellowship - Peggy Buescher and Re Henning

It was noted that Re Henning's name was misspelled in some of the annual meeting bulletins (correction from "Hemming" to "Henning").

Peggy Buescher shared her gratitude for all the help she's received with hospitality in the past year, especially from Re Henning, Barb Turner, and Jerry Buescher. She added that more helping hands are always welcome; those interested should speak with her after church. She noted that serving others through hospitality and other random acts of kindness are ways to show Jesus' love to others.

Sextons' Report - Jim and Paula Minacci

Joy reviewed the sextons' report in Jim's and Paula's absence. The sextons' primary job is cleaning the property, but they also spend much time raking leaves, setting up for events, and problem solving regarding property needs. Joy pointed out that the Sexton Sideshows have been vital to our growth as a community. She encouraged us to thank Jim and Paula for their efforts.

Guatemala Committee Report - Heather Myers

Heather Myers was not present to review this report, so Joy reviewed a few main points. The biggest event of the year was the recent trip to Guatemala that seven of our parishioners took. While there, they provided assistance with several projects. In the past year, we continued to provide medical care and scholarship assistance. Our fundraising goals are less clear at this moment, given that our sister parishes in Guatemala have a new priest, Padre Luis Cuyún. Padre Luis has some new ideas and projects with which he will need our financial support and prayers. These ideas and projects will be shared with the congregation in the fall. In the meantime, there are still handmade items from Guatemala available for sale. The proceeds go directly to our sister parishes.

Music - Paul Fejko

Music Director, Paul Fejko, mentioned that we had thirteen Gloria Dei members who rang bells or sang this year, plus eleven guest musicians who helped us out at various special occasions. Most recently, Gloria Dei acquired a new baby grand piano for Riverside Hall. There will be some piano concerts in the parish hall in the near future. Anyone who is interested in offering their talents as a ringer, singer, or music-maker, should contact Paul.

Inreach Ministry - Rev. Joy Segal

Joy lifted up in thanksgiving all those who participate in this important ministry, whether to pray, write cards, make phone calls, visit, take Communion, or just keep in touch with those who can't make it to church regularly.

Food Ministry - Rev. Joy Segal

Joy reviewed our involvement with the St. John's/Emanuel Food Pantry prior to the closing of St. John's. She mentioned that Emanuel wants to continue the food pantry somehow and she will work with them to find a way for us to be involved again.

Tutoring - Rev. Joy Segal

Joy thanked those who participated last year as tutors at the St. James School in East Falls. Our ministry there is complete for now. There is a new need for tutors at Nebingers Elementary School at 6th and Carpenter. If interested, see Joy, as background checks are required prior to volunteering with the children.

Liturgy Committee - Rev. Joy Segal

Our liturgy committee has chosen all the liturgy, prayers, and creeds for Sunday worship for the past year. Old members rotated off the committee and new ones joined. There will be a mid-summer meeting to plan the fall liturgy. Consider joining us.

Altar Guild - Candace Roberts

Candy thanked all those who participated in Altar Guild in the past year, including those who baked our communion bread (Rita West and Peggy Buescher) and those who supplied the decorations for Christmas and Easter services (Dolores Kromchad). Anyone interested in participating, please see Candy.

Capital Campaign Update - Candace Roberts

The new 501(c)3 ("Historic Gloria Dei Preservation Corporation") was approved in 2012 and has begun organizing. Officers and trustees were selected and will be meeting six time a year in person, four times by teleconference. Anyone interested in joining the Board should contact Candy.

Thank You to the Staff - Rev. Joy Segal

Joy thanked all the staff of Gloria Dei – Terry O'Brien, Jim and Paula Minacci, and Paul Fejko. Megan Bartlett added a thank you to Joy for her leadership.

The days and weeks and months move ever onward, whether we wish it or not. Another year has passed, and it is time again to look at where we have been, where we are, and where we would like to be. Numbers (attendance, pledges, investments, etc.) can tell us something of where we've been, but numbers cannot tell us the "whys" behind them. And so we gather in Annual Meeting once a year to be sure that all voices are heard, all concerns are noted, all joys are celebrated, and the corporate vision has not slipped away from us, or changed into something that no longer reflects who we are as a parish.

Last year I introduced what I called "A New Vision." This new way of seeing ourselves encouraged our understanding of being a part of a greater community, and stressed the need to see ourselves as a member of this community, offering our gifts and assets, seeing those with whom we live and work in new ways, naming them as affiliates, or partners those who share our space and with whom we might be able to share an ongoing vision for the future.

We continue to have a wonderful relationship with The National Park Service (NPS). Much like us, they too are an entity that continues to meet the challenges of a changing world. NPS has taken some financial hits as the US economy continues to be strained. But the devotion to the mission of maintaining the valuable sites entrusted to them continues to be paramount to them. We continue to work in tandem with them, and they with us. The relationships we have made with the employees of NPS continue to be of great value to the safety and seasonal maintenance of the parks surrounding our property. In this way we are able to host many events, knowing our property will be in good order.

We have become more active with the Queen Village Neighborhood Association (QVNA), recognizing that we are members of this organization and the importance of our contribution to the needs of the neighborhood as we grapple together with challenges of safety, cleanliness, education, and insuring that we are a neighborhood known for its ambience and its viability as a place where people would want to live and work.

Young Children's Creative Arts (YCCA) continues to thrive on our property. Now in its twenty-sixth year of service to the community, it is a pre-school that maintains an excellent reputation and attracts young marrieds with children to our property all year long. YCCA's presence with us continues to be of great importance both for the income it

contributes to our budget as well as for the presence of children laughing and playing on the property throughout the year.

Seamen's Church Institute (SCI) and Gloria Dei continue to consider the possibility of building a new building on our property. This vision of shared ministry on this historic property by two historic entities is one that we and they still believe worthy of consideration. Complications abound, but we now have architects' renderings and have begun feasibility and engineering studies.

And so, we have worked with our neighbors and friends to reach out, to be more a part of our community, to see ourselves and have others see us as willing partners in an ongoing, ever-changing world.

As a parish community we have begun to step outside our doors. We've always been good at inviting in. Now we are challenged to go out as well. To move outside the walls and seek the needs of the community where those needs are. And so, we have begun to volunteer as Guest Chefs at Ronald McDonald House. (next dates: July 13, 2014; October 19, 2014). We have heard the cries of Episcopal Community Services (ECS) for volunteers and will be offering opportunities to go to those in our city who need tutoring, feeding, clothing, housing, and companionship.

The numbers, finally, do matter as well. We must begin to consider how we will survive in the coming years. As long as income continues to decrease from giving and increase from investments we are not responding to the future in a responsible way. Living as the Body of Christ in the world means a lot of things. We are called to love each other, care for those less fortunate, invite in and include all who come to our door, move into a world in need and shine the light of the love we know in Christ Jesus, and consider how we can bloom where we're planted. The Swedish settlers planted us here, in this beautiful place. We must plan for the future of this place even as we speak the love of God each day to a world in need of such words.

And so we continue into a new year. We'll pray and sing, we'll laugh and cry, we'll see new ways to be church, we'll honor our history and our heritage, and we'll give thanks for the work we have been given to do. Let us go forth, to love and serve the Lord. Thanks be to God!



Financial Report - David Hammond


The pie chart below indicates where our 2013 church revenues came from. You may note that the vestry approved a distribution of the principal of one endowment fund in order to balance the budget. The amount withdrawn was significantly less than had been anticipated but is nonetheless a disturbing trend. Our regular support (plate and pledges) again lags significantly below other churches of similar size in the diocese. Our endowments and rentals make up 57.6% of our revenues

2013 Revenue: \$276.6



The pie chart below indicates just how the revenue was spent. There were no real surprises and followed the normal pattern of expenses with one exception and that was in the event category. Purchases for the St. Eric's Fair were up significantly due to rounding out the assortment which had gotten somewhat stale over the past 5 years. The Sexton Side Show financials were changed to reflect the cost of producing the event as a separate line item. Previously the expenses were subtracted from receipts.

Gloria Dei finished 2014 in a strong financial situation thanks to the improvement in the stock market and its effect on our endowments. Endowment distribution was up about \$6,000 in 2013 and will be higher again in 2014 due to the three year averaging.

Vestry Report - Barbara Potts

The Vestry began their 2013-2014 year with a May dinner to thank outgoing members and welcome newly elected members. Meetings were held in June and July and along with conducting the usual business (finances, property, rector's and rector's warden's report, etc.) Vestry members discussed participating in a fall retreat. Gloria Dei parishioners, along with members of the Vestry, availed themselves of the many opportunities for service and fun in support of the many activities and fundraisers that have become a constant in our church and community. As last year quickly progressed to 2014, the Vestry met and broke bread with the bishop, and began to plan for the events of the Lenten season, upcoming elections, and preparations for the annual meeting and spring/summer events. Gloria Dei and its Vestry members are in partnership with the HGDPC, YCCA, QVNA and SCI. We seek to support our congregation, our rector and our surrounding community in our ongoing efforts to grow, with the future always in our sight. Our meetings are open to all and we especially encourage any member of Gloria Dei to join us at any meeting, or become a part of our active Vestry as an elected member!

Sunday School Report - Jill Duink

This year Gloria Dei's children and teachers continued to learn and grow together through Godly Play. We were honored to have Megan Bartlett talk to us about God's service and to have Esther Duink describe her experiences in Guatemala.

In September and October the children learned more about God's people, including the journeys of Abraham and Sarah, Ruth, King David and the prophets. In November and December, we prepared for the birth of Jesus by learning about Joseph, Mary and Elizabeth as well as Saint Lucia and Saint Nicholas. This winter and spring we learned about the life, teachings and healings of Jesus. Our children wonder and talk about the stories. Using the Godly Play stories and materials, our children touch, share and expand the stories. From week to week, the children remember the stories and they make the stories their own.

As one of the teachers, I am often amazed at how much I learn from the simple preparation for and the simple telling of these powerful stories. Two weeks ago I told of Jesus' healing of the ten lepers. That story, first learned back in my Sunday School days, came alive for me. Today I'm preparing to tell of Jesus' last week in Jerusalem. It is difficult to understand how deep the stories from the Bible are and how they shape us. Somehow the stories are renewed in the Sunday School circle. Somehow the children make them wondrous again.

Like our congregation, our Sunday School class is small but powerful. It is wonderful to see the children sing, share, trust and grow together.

Next year, we invite you to share your experience, talents, and wisdom with the children. We look forward to knowing more of you through special visits to our classes. Those interested in joining the teachers or volunteering are welcome. I would love for someone with musical talent to help us prepare something to share in church. For the children, we look forward to deeper friendships, deeper wondering, and to deeper, growing relationships with God.

Property Committee Report - Rev. Joy Segal

As I say every year - "Property" is a big word at Gloria Dei. We have a lot of it, and it requires a lot of attention. Over the past few years we have managed to address quite a number of issues, and those that we cannot afford to remedy at the present we have identified and insured that matters will not get worse while we await funding.

During the summer of 2013 we continued the restoration of the graveyard, cleaning and restoring a number of stones and opening a vault. We spent all we had raised for this project, about \$6000.00. We also continued a long loved project of planting our Easter flowers in the graveyard, insuring that each year we can enjoy the wonders of flowers that bloom, even in the heart of a busy city. We hear many compliments about how well we are keeping the property, now that the graveyard is showing its beauty and we are showing our love of this property.

The vestry approved, once again, the use of funds this year from one of our unrestricted funds to address property issues as well as what we are calling "Growth and Transformation" opportunities. The use of these funds allowed us to complete many things we would otherwise not have been able to do. The list of items completed reflects this reality.

Property and Growth items completed since last Annual Meeting

- Tree maintenance through the property
- Baby Grand Piano in Riverside Hall
- New central A/C unit in the rectory
- Partial rewiring in the church
- Floors refinished in Riverside Hall
- Conversion to Comcast phone and internet
- New 70" screen in Riverside Hall
- WiFi in Riverside Hall
- Many banners and sandwich boards
- Continued all-inclusive Sunday bulletins

The Vestry has approved use of additional funds from the same unrestricted fund for use this year, allowing us to consider other items and issues, many left undone last year but still under consideration.

Property items under consideration

- Closed circuit capability from church to Riverside Hall and the Roak Room.
- Sanctuary Floor repair
- Rebuild brick piers adjacent to amphitheater
- Install light given to us by NPS
- Painting/Pointing Rectory
- Pointing Sexton's House
- New chairs Riverside Hall
- Paving driveway, all or portions of parking lot
- Install new baseboard heat in center rooms, 3rd floor and basement, of Roak House

- Leveling of brick pathways incl. drainage system work as needed.
- Leveling of the Sexton House patio
- A/C Riverside Hall
- Banners, sandwich boards
- Continue all-inclusive Sunday bulletins

Liberty Tree and Landscape once again spent five days working on our trees this year, and this fourth year of professional care has added to the trim, clean, well-tended look of our property as well as assured us that safety issues caused by dead tree branches untended are no longer a worry for us.

We are still not financially ready to tackle the more expensive projects, but we now have our new Historic Gloria Dei Old Swedes Preservation Corporation (HGDPC) up and running. That Board will soon be applying for grants to help with these – Sanctuary floor repair, painting and pointing of the Rectory, pointing of the Sexton House, leveling of brick pathways and repair of drainage systems, complete repaving of the parking lot, leveling of the Sexton House patio, air conditioning of Riverside Hall.

Additionally, the possibility of Seamen's Church Institute joining us on our property and together building a new space for all of us to do ministry will necessarily change some of these plans.

Meanwhile we will continue to rely on the great talent within our congregation and the wonderful offering of time, talent and treasure from so many volunteers.

Gloria Dei Church has been on this property, making a difference within the community, since 1677. Our conscious efforts to maintain it for future generations mirror the efforts of those who came before us and, hopefully, set an example for future generations who will discover in years to come the sacred space we call Gloria Dei.

History Committee Report - Jeanette Woehr

In November, the History Committee hosted our first seminar of the three Swedish Lutheran Churches, Gloria Dei, Christ Church Upper Merion, and St. James Kingsessing. The group that gathered is hopeful the seminars will continue in the other two churches.

Requests for genealogical information still are being answered.

Restoration of the graveyard and research into the lives of those buried under the restored stones continues.

Due to the bad weather this winter, the committee has not met that often. Now that the weather is warmer we will begin our weekly sessions of recording the many documents in our archives. Currently we are finishing up with the 1800 papers. If you are interested in joining our group, please let me or one of the committee know of your interest. It is a fun group who often stops our recording work to check out locations referred to in the document being recorded.
