## 1. Welcome

The bishop opened the meeting with prayer and welcomed the members of diocesan council. Bishop Logan thanked the members of St. Mary, Nanoose Bay for use of their parish hall for today's meeting.

Selinde Krayenhoff welcomed diocesan council to the meeting being held in the parish's newly renovated hall. Selinde shared that the parish hall is used extensively for community activities and parish-driven community dinners and other functions.

Bishop Logan acknowledged that we are on the lands of the Nuu-chah-nulth and the Snaw-naw'-as nations.

The bishop then spoke about his written remarks (attached to the minutes of this council meeting), which were provided to diocesan council as part of their meeting package. He reminded council that we are the "synod between diocesan synods" and that our journey of reconciliation has "only just begun."

The bishop thanked all members of the diocese for their support during his family's recent bereavement.

### Vision Reflection on a Season of Discipleship

Lynn Schumacher

Lynn shared several observations regarding her own journey toward her expression of her faith. She shared her understanding of how Canon Ian Alexander's material for this meeting reinforced how we, as a diocese, are at an important crossroads and how we are going to move forward as a diocese. She raised several questions which she asked council to consider:

- 1) Would anyone know that I am a follower of Jesus Christ by the way I lead my life?
- 2) How important is it that I attend church services regularly?
- 3) What do I get spiritually and materially through attendance in church?
- 4) Why am I an Anglican?

Lynn then shared three pieces from Peter Millar's book, An Iona Prayer Book:

- a) A poem by George MacLeod
- b) A meditation by the author, Peter Millar.
- c) A piece from South Africa

Time for quiet personal reflection was given.

### Doing God's Work Together

Canon Ian Alexander

Through the use of pre-session self-identification charts, directed discussion and plenary sessions, Canon Alexander facilitated diocesan council in examining their perception of how we, as a diocese, can move forward into the next three-year period of discipleship. Diocesan Council broke for lunch following Canon Alexander's presentation and discussion. Following the break, Michael Wolff thanked the parish members from St. Mary's for providing lunch for council.

## 3. Living the Vision #1

a) Transforming Futures – Update

Walter Stewart

Co-chair Walter Stewart provided diocesan council with an update on the progress of Transforming Futures. More parishes have begun the process of forming their teams, developing their case for support and beginning the work of rolling out their parish program. He noted that there has been a gross under-estimation of the time required for case development and that parishes need to do the case development to a much higher level than originally understood. In many parishes, there exists no capacity to dream. Their focus is on survival and this has robbed all opportunity to dream that which they might do. Even if parishes are not prepared to go forward with a Transforming Futures campaign until 2022, it would be wise to get your Transforming Futures team together and to begin the development of your case for support.
