# **Committee Reports:**

#### **Old Business:**

Online worship has been progressing smoothly, as has the transition to one 10 am in-person service on Sundays. Pastor Pat reported that approximately 75-85 people are watching Wednesday services online, and approximately 100 are watching on Sundays.

The Covid-19 Advisory Task Force will continue meeting monthly, with the next meeting on July 27<sup>th</sup> at 1:00 pm.

The Preschool Advisory Board will meet on July 28 to discuss plans for the fall. The feasibility of a return to school and options for teachers and students will be discussed. A decision will be made by August 3 as to whether the school will reopen in the fall.

## **New Business:**

Financial consultant, Mike Ward, sent a letter detailing his proposal to work with the council on strategic planning for the next 3-5 years, debt elimination, and modified committee structure. The plan would involve 6 months of strategic planning including a silent campaign to solicit large donors for debt elimination. An active campaign would follow some time during 2021. The fees for the strategic planning, governance, and silent campaign would be \$6,000, plus some additional fees once the silent campaign is underway. Ivan Black moved that we engage Mike Ward to assist with the campaign, and that we authorize up to \$10,000 in expenditures during the initial phase of the campaign. Christy Wenzel seconded the motion which passed unanimously.
