Bishop Halaas announced, that, in accordance with Synod Constitution S8.55, Tracy Gayer has been appointed Synod Vice President. Bishop Halaas thanked Tracy for his willingness to serve in this capacity.

Tracy Gayer called the meeting to order.

Bishop Halaas offered an opening prayer.

## SC20.08.1 APPROVE the agenda.

Motion made and seconded by: Michael Jacobson, Kim Peterson; PASSED.

There was no correspondence.

Karen Post relayed recent communication with the Churchwide Secretary and Synod Attorney (Jay Denne) regarding meetings/voting in current Covid restrictions. Encouraged congregations to update constitutions in sync with Model Constitution for Congregations (2019) if non-in-person congregational meetings are desired.

**SC20.08.2** APPROVE the June 13, 2020 Synod Council minutes. (See the "Reports" Google folder.)

Motion made and seconded by: Cole McCormick, Kathy McEnelly; PASSED

Michael Jacobson reviewed the July financial statements (see the "Reports" Google folder) and feels that our cash position is strong, helped by: the \$86,067.50 Small Business Administration's (SBA) Payroll Protection Program (PPP) loan received in May, and steady Mission Support received from congregations.

The Synod Council discussed sending \$25,000 to Churchwide and transferring \$25,000 to the "Reserve for Admin" (see May Synod Council minutes detailing provision S15.14 of the Western Iowa Synod constitution).

**SC20.08.3** RECEIVE the treasurer's report, including \$25,000 to Churchwide and a \$25,000 Reserve for Admin transfer.

Motion made and seconded by: Karen Post, Kathy McEnelly; PASSED

Discussed the upcoming April 2021 office balloon payment, potential building repairs and various office/building alternatives. Michael will investigate tax consequences of sale of the office building. Kay and Bishop will investigate the real estate market in Storm Lake and the cost of the gas line building repairs.

## **New Business:**

- 1) Open Synod Council positions:
  - a) Hands of Hope (Tracy Gayer replacement) lay male (2 years remaining) Note: Wayne Pfannkuch's name (clergy) was offered, but that would have been for this conference's 2020 assembly election (those didn't happen). Only unfilled terms are being filled at this time.
  - b) Abundant Fields lay male (1 year remaining)
  - c) Rivers of Grace lay female (2 years remaining)

- 2) Lizard Creek Ranch, Fort Dodge November 21, 2020 This is planned to be a day of thanksgiving, worship, fun, observance of rostered ministers and congregation anniversaries, the 50<sup>th</sup> anniversary of women's ELCA ordination, an auction for the Fund for the Future, etc, (no synod assembly business). Check the e-Spirits for updates.
- 3) Synod Assembly is planned for April 9-10, 2021.
  - a) We have a tentative agreement with Fort Frenzy in Fort Dodge; the assembly may instead be held online, depending on the Covid situation.
  - b) Bishop Halaas discussed the intention to have an assembly planning committee, separate from the Assembly of Business and Counsel (ABC). The assembly planning committee would be in charge of technology, meals, logistics; leaving ABC for nominations, resolutions and business.
